Also excluded from the scope of this Order are crystalline silicon photovoltaic cells, not exceeding 10,000mm<sup>2</sup> in surface area, that are permanently integrated into a consumer good whose function is other than power generation and that consumes the electricity generated by the integrated crystalline silicon photovoltaic cell.

What are BIPV products?

BIPV products are materials integrated into the building envelope, such as the facade or roof, containing CSPV cells.
