What is a report filter in MicroStrategy?

The stand-alone filter can then be used on many different reports, as well as on metrics and other objects. However, in MicroStrategy, filters can also be created as part of a given report, at the same time the report itself is being created. These kinds of filters are generically called report filters.

What is the MicroStrategy basic reporting guide?

MicroStrategy Report Services documents are available with MicroStrategy Report Services. Dashboard-style documents are a display of data from multiple reports with special formatting added, with interactive components, and so on.

Should MSMEs use the GRI framework to produce sustainability reports?

A small number of MSMEs had looked at the GRI framework as a possible basis for producing sustainability reports. All considered the framework prohibitive relative to their internal resources - as well as the likely costs versus potential returns from issuing a first sustainability report.
