What does the European Commission say about energy storage in Spain?

Will Spain be able to deploy large-scale electricity storage?

The European Commission has approved a new aid scheme that will allow Spain to deploy large-scale electricity storage, both in hybridisation with renewable energy facilities and stand-alone and thermal.

Does Spain have a blackout policy?

Spain continues to adjust policy and make sweeping changes to both prevent a reoccurrence of a major blackout, while supporting standalone storage and hybrid projects. Spain has published Royal Decree 997/2025 in the Official State Gazette (BOE) following its announcement earlier this week.

What does the new EU Regulation mean for energy storage?

The new regulation aligns with European Union Regulation 2019/943 by formally recognizing storage as a flexibility technology that enhances renewable energy integration and system stability.

Spain has overhauled its grid-access rules to support energy storage, granting hybrid renewables-plus-storage projects equal dispatch priority and full revenue rights for stored electricity.

The decree explicitly classifies energy storage facilities and their associated grid connection infrastructure as "public utility" for the first time. This grants them legal support equivalent to power ...
