



# Photovoltaic panel factory export tax rebate policy

When will the photovoltaic export tax rebate be canceled?

On January 8, 2026, the Ministry of Finance and the State Taxation Administration issued an announcement, clarifying that the export tax rebate for photovoltaic and other products will be canceled starting from April 1, 2026.

Will China change export tax rebates for photovoltaic & battery products?

China announced on Friday that it will change export tax rebates for a range of products, including photovoltaic and battery products.

What is the new tax rebate rate for photovoltaic products?

This follows the previous adjustment in December 2024, which reduced the export tax rebate rate for photovoltaic products from 13% to 9%.

Does China have a VAT rebate on solar products?

Effective April 1, 2026, China will completely eliminate VAT export rebates for 249 products. This includes solar cells, modules, inverters, and related components. Previously, many Chinese solar manufacturers received 13% VAT rebates on exports--reduced to 9% in December 2024 for affected product categories.
